Why Organics?

Timeline for Compliance

January 1, 2022

By CA law, all multi-family properties are required to have organics service.





Required Services

Organics



Mixed Recyclables

- Clean, Dry Paper
- · Cardboard and Chipboard
- Plastic containers
- Metal and aluminum containers
- Glass containers

City's Service Level Requirements

Organics 64-gallon can for every 25 units

County does not have a minimum requirement


Recycling 1-yard bin for every 16 units

How to Comply





Start Organics and/or Recycling Service

Contact your current hauler to add organics collection service

- All haulers have cart services small as 64 gallons on wheels
- You may choose any franchised hauler. You are not required to use the same one that provides trash service.

Alternative Service

Requires submitting an Organics Material Recycling Compliance Form and proof such as weight receipts and service agreements.

Options include:

- Third-party recycler
- Self-haul
- Shared container with adjacent property.



Compliance Forms

- 1. Verify your jurisdiction apply with correct jurisdiction.
- 2. Gather required documents prior to submitting.
- 3. Retain records for mandatory inspection.
- 4. Unsure? Ask your jurisdiction before submitting.

The following types of waivers can be requested:

20-Gallon or Less Business generates less than 20 gallons of organic material per week.

Physical Space Business does not have adequate space for an organic material container

Physical Space

Submitting Alternative Service Verification Only, No Waiver Needed

20-Gallon or Less Waiver Requirements

A 20-Gallon or Less Waiver may be granted if a business generates less than 20-gallons of organic material per "clean wood" (no paint, no stain, etc.]) into a measurable bucket(s) for one or more representative week(s). If th

Note: If a portion of your organic material is already being recycled, such as your green waste/landscaping trim than 20 gallons, you should request both a 20-Gallon or Less Walver and submit an Alternative Services Verificath

Ineligible Businesses

The following businesses are ineligible for a 20-Gallon or Less Waiver.

1. All businesses that require a permit from Sacramento County Environmental Management Department (EN

2. Businesses that make food

- Restaurants
- Food service business (caterer, food pantry/closet, or any business that sells or serves food)
- Food manufacturer
- Wholesale food vendor
- Grocery store
- Supermarket
- Market / mini mart serving coffee and/or selling food

3. Businesses that serve food




Jurisdiction Information

- Why is understanding your location important? Only the jurisdiction where your property is located can assist you with compliance.
- To check your jurisdiction:
 - ✓ Assessor Parcel Viewer (<u>https://assessorparcelviewer.saccounty.gov/</u>)
- Did you know?
 - Incorporated Cities typically have blue or green street signs
 - \circ $\,$ County of Sacramento has white street signs with black lettering

I don't have space for this!

- Not all properties may have sufficient space for all three bins.
- Space waiver requests will be reviewed by staff on a case-by-case basis, by property.
- Criteria:
 - 1. Do you already have both trash and recycling service?
 - 2. Is there enough space in the existing trash enclosure?
 - 3. If not, is there sufficient space nearby, such as an existing parking space or an open area?



Remember: a smaller 64-gallon can may be all you need!





Requesting a Space Waiver

Currently, waivers may be granted by law only for certain circumstances

- Staff will review each application for approval on a <u>case-by-case</u> basis
- Waivers are not permanent, per California law
- ALL granted waivers require an inspection within 5 years

Organics Waivers:

 Physical Space (*Rare*) – Only granted if there is not physical space for the smallest bin or cart available, even after adjusting other services (ex: 64-gallon cart is 32"x24"x42")

Recycling Waiver:

 Physical Space (*Rare*) – Only granted if there is not physical space for the smallest bin or cart available, even after adjusting other services (ex: 64-gallon cart is 32"x24"x42")





Educating Your Tenants



Label Cans and Bins

Ask your hauler for labels.

Distribute Outreach and Education Materials to Employees and Tenants

Ask your hauler for education materials or find items to download on the City and County websites.

Provide Ongoing Outreach and Education

Educate tenants of these new requirements when service starts, as well as:

- 1. New tenants within 14 days as part of move-in.
- 2. All tenants annually.

Labels and tenant education are required by California state law.

Options for compliance:

- 1. Contact an authorized garbage hauler Each jurisdiction's website will have an authorized garbage hauler list
- 2. Get alternative service
- 3. Obtain a physical space waiver (rare)
